

Counseling and/or Risk Factor Reduction Intervention Services Payment Policy

Policy

Fallon Community Health Plan will reimburse for covered individual counseling and/or risk factor reduction intervention services provided by credentialed and contracted providers

Definitions

This policy applies to the payment for professional counseling and/or risk factor reduction intervention services rendered by contracted providers. Counseling and/or risk factor reduction intervention services are provided to individuals at a separate encounter for the purpose of promoting health and preventing illness or injury.

Reimbursement

FCHP will find counseling and/or risk factor reduction intervention services mutually exclusive to evaluation and management, consultation, and preventive medicine services and will not be reimbursed. Telephone consultations or telephone counseling does not qualify for payment under this policy.

Referral/notification/preauthorization requirements

Not applicable.

Billing/coding guidelines

Use the following CPT codes:

99401: Preventive medicine counseling and/or risk factor reduction intervention(s) provided to an individual (separate procedure); approximately 15 minutes.

99402: Preventive medicine counseling and/or risk factor reduction intervention(s) provided to an individual (separate procedure); approximately 30 minutes.

99403: Preventive medicine counseling and/or risk factor reduction intervention(s) provided to an individual (separate procedure); approximately 45 minutes.

99404: Preventive medicine counseling and/or risk factor reduction intervention(s) provided to an individual (separate procedure); approximately 60 minutes.

99406: Smoking and tobacco use cessation counseling visit; intermediate, greater than 3 minutes up to 10 minutes.

99407: Smoking and tobacco use cessation counseling visit; intensive, greater than 10 minutes.
