Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	<b>\$3,000</b> person/ <b>\$6,000</b> family. Doesn't apply to preventive care.	Generally you must pay all the costs from providers up to the <b>deductible</b> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <b>deductible</b> until the total amount of <b>deductible</b> expenses paid by all family members meets the overall family <b>deductible</b> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <b>Preventive care</b> and primary care services are covered before you meet your <b>deductible</b> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply.

Will you pay less if you use a <a href="#">network provider</a> ?	Yes.
