Are there services covered before you meet your deductible ?	No.	This plan does not have a deductible .

What is the out-of-pocket limit for this plan ?	For covered services with in-network providers : \$4,000/person or \$8,000/family.	The out-of-pocket limit is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? Yes.
