What is the overall <a href="#">deductible</a> ?	\$2,000/individual contract or \$4,000/family contract for in-network services. \$4,000/individual contract or \$8,000/family contract for out-of-network services.	Generally you must pay all the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you elect individual coverage, you must meet the individual coverage deductible amount. If you have family coverage, family members must meet their own individual minimum annual <a href="#">deductible</a> of \$2,700 as defined by the IRS guidelines until the family deductible has been met.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> and primary care services are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply.
