Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	<b>\$2,000</b> person/ <b>\$4,000</b> family. Doesn't apply to preventive care.	Generally you must pay all the costs from providers up to the <b>deductible</b> amount before this <a href="#">plan</a> begins to pay. If you elect individual coverage, you must meet the individual coverage deductible amount. If you have family coverage, family members must meet their own individual minimum annual <b>deductible</b> of \$2,700 as defined by the IRS guidelines until the family deductible has been met.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <b>Preventive care</b> is covered before you meet your <b>deductible</b> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply.
Are there other <a href="#">deductibles</a> for specific services?	No.	You don't have to meet <b>deductibles</b> for specific services.
What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	For covered services with in-network <b>providers</b> : <b>\$6,650</b> /person or <b>\$13,300</b> /family.	The <b>out-of-pocket limit</b> is the most you could pay in a year for covered services. If you have other family members in this <a href="#">plan</a> , they have to meet their own <b>out-of-pocket limits</b> until the overall family <b>out-of-pocket limit</b> has been met .
What is not included in the <a href="#">out-of-pocket limit</a> ?	Premiums, balance-billed charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <b>out-of-pocket limit</b> .
Will you pay less if you use a <a href="#">network provider</a> ?	Yes. See <a href="http://www.fallonhealth.org/plandocs">www.fallonhealth.org/plandocs</a> or call 1-800-868-5200 for a list of participating <b>providers</b> .	This <a href="#">plan</a> uses a <b>provider network</b> . You will pay less if you use a <b>provider</b> in the plan's <b>network</b> . You will pay the most if you use an <b>out-of-network provider</b> , and you might receive a bill from a <b>provider</b> for the difference between the <b>provider's</b> charge and what your <a href="#">plan</a> pays ( <b>balance billing</b> ). Be aware, your <b>network provider</b> might use an <b>out-of-network provider</b> for some services (such as lab work). Check with your <b>provider</b> before you get services.
Do you need a <a href="#">referral</a> to see a <a href="#">specialist</a> ?	Yes.	This <a href="#">plan</a> will pay some or all of the costs to see a <b>specialist</b> for covered services but only if you have a <b>referral</b> before you see the <b>specialist</b> .
