| What is the overall deductible ? | \$3,000 person/ \$6,000 family. Doesn't apply to preventive care. | Generally you must pay all the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . |
| Are there services covered before you meet your deductible ? | Yes. Preventive care and primary care services are covered before you meet your deductible . | This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. |
| Are there other deductibles for specific services? | No. | You don't have to meet deductibles for specific services. |
| What is the out-of-pocket limit for this plan ? | For covered services with in-network providers : \$8,150 /person or \$16,300 /family. | The out-of-pocket limit is the most you could pay in a year for covered services.
