MASSACHUSETTS REQUIREMENT TO PURCHASE HEALTH INSURANCE:

As of January 1, 2009 the Massachusetts Health Care Reform Law requires that Massachusetts residents, eighteen (18) years of age and older, must have health coverage that meets the Minimum Creditable Coverage standards set by the Commonwealth Health Insurance Connector, unless waived from the health insurance requirement based on affordability or individual hardship. The following apply to your *Member Handbook/ Evidence of Coverage*:

Your deductible is \$7,150 if you elected individual coverage. Your deductible is \$14,300 if you elected family coverage. Your deductible will be adjusted annually to equal the maximum out-of-pocket costs at the level of the federal Health Savings Account limit. Your first three (3) non-preventive primary care office visits will be covered with a \$35 copayment per visit and will not be subject to your deductible. Each member must meet the per-member deductible amount. No individual member will pay more than the per-member deductible in a benefit period. This plan **does not** cover pediatric dental benefits. Your costs for covered services are described in this Schedule of Benefits; for detailed information on covered services and any exclusions or limitations that apply, we recommend that you refer to the *Member Handbook/Evidence of Coverage*.

Age limits for members

This is a catastrophic plan. In order to purchase this plan, you must be under thirty (30) years of age or have a certificate of exemption for the reasons identified in Section 1302(e) of the Affordable Care Act. You are covered for individual coverage as described in your *Member Handbook/Evidence of Coverage*.

Related exclusions

1. Orthoptic or vision training, subnormal vision aids and any associated supplemental testing; Aniseikonic lenses.
2. Medical and/or surgical treatment of the eye, eyes or supporting structures.
3. Any eye or vision examination, or any corrective eyewear required by a policyholder as a condition of employment; Safety eyewear.
4. Services provided as a result of any Workers' Compensation law, or similar legislation, or required by any governmental agency or program whether federal, state or subdivisions thereof.
5. Non-prescription lenses and/or contact lenses.
6. Non-prescription sunglasses.
7. Two pair of glasses in lieu of bifocals.
8. Services rendered after the date an insured person ceases to be covered under the policy, except when vision materials ordered before coverage ended are delivered, and the services rendered to the insured person are within 31 days from the date of such order.
9. Services or materials provided by any other group benefit plan providing vision care.
10. Lost or broken lenses, frames, glasses, or contact lenses will not be replaced except in the next benefit period when vision materials would become available.
