### MGH and B&W providers on board

Similarly, FCHP Select Care members now have full access to Massachusetts General Hospital (MGH) and Brigham and Women's (B&W) Hospital, and their more than 3,800 primary care providers and specialists.

For a second opinion and treatment for specialty services, the program guarantees their access to Beth Israel Deaconess Medical Center, Brigham and Women's Hospital, Children's Hospital, Dana-Farber Cancer Institute, and Massachusetts General Hospital as long as they meet program eligibility criteria.

#### ■ Customized employee wellness

We hope you'll take advantage of The Healthy Health Plan—our easy-to-implement wellness program that effectively encourages employee participation. This new program supports FCHP subscribers for being—and becoming—healthy by rewarding them with financial incentives. It's available with FCHP commercial plans at the time of a member's enrollment anniversary.

Once offered the plan, subscribers go to fchp.org/healthyhealthplan to log in to the My Healthy Health Plan portal, fill out the health assessment, and be eligible to receive up to \$200. The My Healthy Health Plan portal offers customized action health plans that include health coaching, wellness workshops, interactive tools and more. (The financial incentive is available to subscribers only, but family dependents may take advantage of the portal, too.)

Mini clinics are walk-in clinics that offer an alternative to emergency rooms for common sicknesses like strep throat, bronchitis, cold/flu, minor burns, rashes, and ear, eye, bladder and sinus infections. They are open 7 days a week, with convenient evening hours. No appointment or referral is needed. For more details, go to fchp.org and search "mini clinics."

Members are covered for treatment received at any of the more than 40 **MinuteClinic®** locations in CVS/pharmacy stores in Massachusetts. For details and locations, see minuteclinic.com.

Similarly, members are covered at **ReadyMED™** by Reliant Medical Group—a walk-in medical facility at 222 Boston Turnpike (Route 9 East), Shrewsbury, Mass., and newly opened at 460 Southbridge St. (Rt. 12) in Auburn, Mass. Lab and X-ray services are on site. For information, see readymed.org. ■

### Doing business with us

### ■ Company may call employers on our behalf

Over the past year, FCHP has worked with Discovery Health Partners (DHP) to maximize our subrogation process and results, and help us with coordination of benefits when a member has coverage from two or more insurers.

As part of this process, DPH may call you to gather information, such as (but not limited to) the employer's group size and if the employee is actively working. Their calls are legitimate, and your answers are important to our post-payment recovery efforts.

Subrogation is identifying, and getting reimbursement from, another payer that is responsible for medical claims we paid relating to a member's injury, such as a car accident, worker's compensation and a slip or fall injury.

# ■ Employers have easy premium payment options

You have different ways of doing business, so we offer you different options for paying premiums.

- -Automated Clearing House: You can arrange a one-time premium payment by automatic withdrawal from a bank account. A more convenient alternative is to arrange ongoing payments. FCHP debits the total premium billed to your bank account on the due date. We also can credit any amounts that you are owed directly to a bank account. For either ACH option, you must complete and submit our Automated Clearinghouse Transfer Authorization form at fchp.org/employers/resources.
- -Checks: You can mail us an original check in the mail. To avoid misapplied premium payments, the check should include the business name and/or FCHP customer number and be made payable to Fallon Community Health Plan.

### ■ Reporting fraud, waste and abuse

Fraud, waste and abuse affect everyone. Combating fraud, waste and abuse is essential to maintaining strong and affordable health care coverage.

- Fraud can be defined as an intentional misrepresentation that causes a victim to part with something of value, and is considered a criminal act.
- Waste is generally categorized as an act that causes a company to pay unnecessarily for a service.
- Abuse occurs when an individual or entity "works the system," so as to be paid (or paid more) for a service to which he/she would not otherwise be entitled.

Fallon Community Health Plan is committed to detecting, investigating and resolving instances of fraud, waste and abuse. - 1 non-fat yogurt cup and 1 piece of fruit (260)
- 2 cups air popped popcorn and a box of raisins (145)
- 8 baked tortilla chips and salsa (70)
- 1/4 cup raisins and 2 tablespoons of sunflower seeds (200)
- 1 cup fruit salad and 5 whole-grain crackers (160)
